Establishing a Particular Partnership Company in Saudi Arabia is authorized by Saudi Companies Law. Companies in Saudi Arabia can be formed under different identity shape and Particular Partnership Company is one of those shapes. However, there is a big debate related to this kind of companies. In this context, I would like to dig deeper in this particular topic, especially when we know that this kind of companies has a hidden identity nature with the absence of physical existence comparing with other companies; in addition, it has independent financial disclosure, and it is not subject to publicity, also most of the time it has no name; leads to uncertainty situation for those who deal with such kind of companies. For that reason, I am discussing different aspects related to this kind of companies, talking about Commercial Particular Partnership Company as a concept in general, passing by its characteristics and main traits. Then, I am elaborating on some other details such as; how to convert the Particular Partnership Company into different type of companies, and what are the general and special core requirements to establish a Commercial Particular Partnership Company.
